A step-by-step plan for registering as a Referral Partner


Step 1 Registration

Step 2 Approval of your registration

After you fill out the registration form, your application will be sent to our team for verification. Within 24 hours, we will review the application and approve it, notifying you via the email you provided during registration.



Step 3 Log in to your account

Step 4 Default Referral Link

By logging into your account/dashboard, you will be able to see your default referral link, which you can share with your friends/colleagues.

When someone clicks your referral link and visits our site, we install a cookie on their browser.

Our cookie lasts 6 months. As long as your referee signs up for our services within that 6 months then you will be credited with the reward.

For example: A 6-months cookie duration means that from the moment your friend/ colleague (Referee) clicks on your referral link, you have up to 6 months to earn a reward if they decide to sign up for Access Financial services.

If they sign up after 6 months, the cookie will have expired, and you won't be credited with the reward.

Step 5 Generate a custom link

Since the default referral link will direct your friends/colleagues to the main page of Access Financial (<u>https://accessfinancial.com</u>), if necessary, you can create a custom link to any other page on our company's website by entering the URL of that page in the 'Page URL' field and clicking the 'Create Custom Link' button.
